



a. The project of PWD was considered by UTRTEC Working Group in its meeting on 27.09.2023. The project was approved by the UTRTEC Governing Body with the following decisions / observations -

- i. Service road along main belt upto the District Court may be retained to avoid competition due to merger of left and right turning traffic at Mathlaban Chowk.
- ii. Traffic from Mathlaban Chowk going left into Purnima is presently weaving with the buses going to Mathlaban Chowk underpass, which needs to be properly addressed in the proposal.
- iii. A new foot over bridge has been proposed along the existing pedestrian underpass, which will cause a bottleneck and shall be reconsidered.
- iv. Height of the median line passing through the Mathlaban Chowk intersection, allows a two level junctions one low height and other full height. The options may be explored.
- v. 20 meter Roads from Purnima and Rohini sector 9 (900 to 700 CH) should have appropriate entry/exit from OHR.
- vi. Integration of grade separations at Mathlaban Chowk with the existing RoB and new elevated road proposal be shown on the drawing.

Observations / Suggestions:

- i. As far as possible the continuity of interference-free footpaths and cycle tracks at intersections be shown.
- ii. Inter-urban management jurisdiction plan for an area of around 1 km along the both sides of OHR proposed. Two 50m may be provided at the intersections, even in case of signalised crossing.
- iii. Sign roads and service roads, wherever feasible, may be provided.
- iv. Width of service road including footpath, may be at least 7.5 meters.
- v. Provisions for segregated lanes and facilities for public transport system, including bus stops, be ensured.
- vi. Traffic signals be shown at all intersections with provision for separate signal plans for cars, buses, NMT. Signal timings be calculated as per the traffic projections.
- vii. Location of signage be shown in the plans.
- viii. The details of affected structures and trees to be given in the feasibility format.
- ix. Right of Way line of all roads as per the Master Plan / Zonal Development Plan be shown in the plan.
- x. A traffic management plan and a work zone Management plan during the construction period be prepared.
- xi. Width of the flyover / elevated road on outer ring road to be maintained as per the existing under pass on Mathlaban Chowk.

b. UTRTEC Governing Body in its meeting held on 20.2.2024 under the chairmanship of Hon'ble U.C. Datta accorded its approval, based on the recommendation and observations of the working group meeting with following additional observations:-

- i. In order to facilitate contact free local movements (pedestrians/cyclists and NMTs etc) junction movement as per advice of traffic police, MCD, and UTRTEC may be incorporated in the proposal.
- ii. Intervention at Mathlaban Chowk should take into account the proposal of zonal plan (Zone P-1), heavy capacity along highway etc.
- iii. Traffic Management / work zone management plan during construction be prepared in consultation with traffic police for the alternative stop of signal 1 km on either side of the road.
